

**PASS TO CHINA SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **SPONSOR:** Disney Destinations, LLC (“Sponsor”), P.O. Box 3232, Anaheim, CA 92803
2. **ADMINISTRATOR:** Prize Logic, LLC (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033, U.S.A., the independent agency administering this Sweepstakes.
3. **ELIGIBILITY:** The *Pass To China* Sweepstakes (“Sweepstakes”) is open only to legal residents of, and who are physically located within, the fifty (50) United States and the District of Columbia (“Territory”) both at the time of entry and on the date of the Trip (as defined below) redemption, who: (i) are at least 18 years of age, as of date of entry, and (ii) have a valid *Disneyland®* Resort or *Walt Disney World®* Resort Annual Passport as of December 6, 2016. Officers, directors, and employees, and members of their household or immediate family (*i.e.*, parents, children, spouse, siblings, grandparents, step-parents, step-children, and step-siblings of each), and persons residing in such immediate family members' household, of Sponsor, Administrator, their respective parent, related, affiliated and subsidiary companies, all other entities involved in the creation, administration, or fulfillment of the Sweepstakes and their respective successors and assigns, are not eligible to enter or win. Participation constitutes full and unconditional agreement to these official rules (“Rules”). Sponsor’s and Administrator’s decisions are final and binding in all matters related to the Sweepstakes. Winning is contingent upon fulfilling all requirements set forth herein. ***Void outside the Fifty (50) United States and the District of Columbia, including but not limited to, Puerto Rico and all United States Territories, and where prohibited or restricted by law.***
4. **HOW TO ENTER:** The Sweepstakes period begins on 12:00:00 PM (noon) Eastern Time (“ET”) on December 7, 2016, and ends at 11:59:59 PM ET on February 28, 2017 (the “Sweepstakes Period”). The Administrator’s computer is the official Sweepstakes clock.

During the Sweepstakes Period, an eligible entrant (“Entrant”) must visit www.PasstoChina.com (“Website”), select “Enter Here” for either the *Disneyland®* Resort Passholder pool (“Disneyland Pool”) or the *Walt Disney World®* Resort Passholder pool (“Walt Disney World Pool”) based on whether he or she is a Disneyland or Walt Disney World passholder, and enter his/her valid e-mail address to submit an entry (each, an “Entry” and collectively, “Entries”). If it is the Entrant’s first time entering the Sweepstakes, the Entrant must enter by providing the information requested on the registration form, which may include without limitation: his/her first and last name (initials are not permitted, unless the initials are part of his/her legal name), his/her annual *Disneyland®* Resort or *Walt Disney World®* Resort Annual Passport number, and affirmation that he/she is at least 18 years old, has met all

eligibility requirements to enter and has read and agrees to be bound by these Rules and the Website's Terms of Use. Entrants will not be allowed to change their physical address or e-mail address after registering. Upon entering, each Entrant will receive one (1) Entry into either the Disneyland Pool or Walt Disney World Pool (each, a "Pool"), as applicable.

Note: If an Entrant accesses the Website on his/her mobile device to enter this Sweepstakes, the Entrant's wireless service provider may charge the Entrant for applicable data charges. Entrants should consult their wireless service provider regarding its pricing plans. Data rates may apply. Entrants should review their mobile device's capabilities for specific mobile application instructions.

Limit of one (1) Entry per Entrant per day during the Sweepstakes Period. A "day" is defined as starting at 12:00:00 AM (midnight) ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on December 7, 2016, when a day is defined as starting at 12:00:00 PM (noon) ET and ending at 11:59:59 PM ET. All Entries are subject to confirmation and/or verification and compliance with these Rules as determined by Sponsor and/or Administrator. Provided an Entrant had a valid *Disneyland® Resort* or *Walt Disney World® Resort* Annual Passport as of December 6, 2016, such Entrant will be permitted to submit Entries throughout the Sweepstakes Period, regardless of Annual Passport membership status. Sponsor reserves the right, in its sole and absolute discretion, to disqualify any Entries that do not comply with these Rules.

5. WINNER SELECTION: On or about March 1, 2017, Administrator will randomly select two (2) potential winners (one [1] winner from the *Disneyland* Pool and one (1) winner from the *Walt Disney World* Pool) (each, a "Winner") from among all eligible Entries received for the respective Pool. Administrator's decisions, along with the Sponsor's, as to the administration and operation of the Sweepstakes and the selection of the potential Winners are final and binding in all matters related to the Sweepstakes. The selected Entrants are each deemed a potential Winner pending verification of his/her eligibility and compliance with the Rules.

6. PRIZES & APPROXIMATE RETAIL VALUE ("ARV"):

A. Grand Prize: Two (2) Grand Prizes will be awarded (one [1] for the Disneyland Pool Winner and one [1] for the Walt Disney World Pool Winner). Each Winner will receive a fourteen day (14) day/thirteen night (13) night *Adventures by Disney®* vacation package to China including a one (1) night pre-departure experience at the Disneyland Resort in California for travel from July 6, 2017 through July 19, 2017 (the "**Trip**") for Winner and one (1) guest ("Guest") (together with the Winner, the "**Group**") consisting of the following:

- If the Winner resides more than 150 miles from the *Disneyland* Resort, coach airfare from a major international commercial airport near Winner's residence ("**Airport of Origin**") to Hong Kong International Airport with a stop at a Southern California area airport on the way to Hong Kong and return coach airfare from the Shanghai International Airport to the Airport of Origin (each as determined solely by Disney, with possible stopovers) for the Group. If the Winner resides within 150 miles from the *Disneyland* Resort, coach airfare from a Southern California area airport (which, in

such case, will be treated as the Airport of Origin for purposes of these Rules) to Hong Kong International Airport and coach airfare from the Shanghai International Airport to the Airport of Origin (each as determined solely by Disney, with possible stopovers) for the Group.

- Round trip ground transfers between the Southern California area airport and the *Disneyland* Resort are provided, (however, if the Winner resides within 150 miles of the *Disneyland* Resort, ground transfers to the *Disneyland* Resort will not be provided to the Group), between the Hong Kong International Airport and the Hong Kong Disneyland Hotel and between the Shanghai Disneyland Hotel and the Shanghai International airport.
- Twelve (12) nights hotel accommodations (one (1) night on an airplane) during the Trip (one (1) standard room/double occupancy per location) consisting of: one (1) night at The *Disneyland*® Hotel, four (4) nights at The Hong Kong Disneyland Hotel, three (3) nights at the Rosewood Beijing Hotel, four (4) nights at The Shanghai Disneyland Hotel.
- Participation in a guided group travel experience with other guests (the “**Group Travel Experience**”) (as determined by Sponsor in its sole discretion). The Group Travel Experience includes entertainment and activities (as determined by Sponsor in its sole discretion), such as visits to the Disneyland Resort in California, Hong Kong Disneyland® and the new Shanghai Disneyland®, special access to attractions, behind the scenes tours, VIP guides, visits to China’s natural wonders and events including the Great Wall, the Forbidden City, Victoria Peak, and Tiananmen Square.
- Services of two (2) Adventure Guides for the Group Travel Experience.
- Transportation within the land package, including travel between hotels, and to and from group excursions.
- On-tour luggage handling.
- Gratuities for two (2) Adventure Guides, bellmen, housekeepers, drivers, activity providers and dining room staff.
- All meals served as part of the Group Travel Experience itinerary (excluding alcoholic beverages), which includes most meals.
- Travel taxes imposed on included transportation, lodging and services.

Trip is pre-scheduled for July 6, 2017 – July 19, 2017. The minimum age for the Trip is six (6) years old at the time of travel and the suggested age for the Trip is eight (8) and older. The approximate retail value (“**ARV**”) of each vacation package is \$24,263. Actual ARV of each Grand Prize depends on the location of the Winner’s residence. Limit: One (1) Grand Prize per person/household.

Please note:

- All Group members must travel together on the same itinerary and the same class of travel. Travel arrangements must be made through Sponsor’s agent and with carriers and accommodations selected by Sponsor. Trip components are subject to change without notice.
- Trip must be booked on or before **May 15, 2017**. Travel must start on July 6, 2017 and be completed on July 19, 2017. Flight details are subject to availability and airline carrier’s regulations and conditions apply. If travel is not booked by **May 15, 2017** or

completed by **July 19, 2017**, the prize will be forfeited without compensation of any kind. No changes will be made to travel details once any element(s) of the travel arrangements have been booked except in Sponsor's sole discretion.

- The Group Travel Experience is not a private tour and may be attended by up to forty-four (44) other travelers.
- Certain terms and restrictions shall apply to the vacation packages, as determined by Sponsor in its sole discretion. If the Group cannot comply with these restrictions, the vacation package will be forfeited in its entirety.

B. Total ARV: The total ARV of all prizes available in the Sweepstakes is \$48,526.00. For all prizes, actual value of a prize depends on the date/time/point of departure/destination and fluctuation of hotel rates and airfares; any difference between the stated ARV and actual value will not be provided.

C. Odds of Winning: The odds of winning a Grand Prize depend on the total number of eligible Entries received for each respective Pool.

D. Prize Conditions: If travel is not booked by required date or completed within the required dates the Grand Prize will be forfeited and Sponsor will have no further obligation to such Winner. *Adventures by Disney* booking, cancellation policies and terms and conditions apply. Group must travel together on the same Trip and must travel from and return to the same Airport of Origin.

All members of the Group will be required to execute and return a Release of Liability prior to participation. Members of the Group are solely responsible for obtaining any and all necessary travel documents (valid photo I.D., credit card, Passport, etc.) before departure and all travelers must be at least 6 years old at time of travel. If any Winner's prize includes international travel, that Winner and his/her Guests must be able to travel to and within the destination country, and return to his/her home country unimpeded. International travel will require a valid passport with six (6) months validity remaining from the last date of travel for all travelers. Any picture identification requirements associated with air travel are the Winner and Guest's responsibility. Guest must be six (6) years of age or older, and if such Guest is under 18 years of age at the time of travel (a "minor"), the Winner must be such minor's parent or legal guardian. Each Winner and his/her Guest hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of a prize. It is the responsibility of each Winner and his/her Guest to arrive at the designated gateway airport in time for each flight that is part of the prize.

All expenses not specifically mentioned herein are not included and are solely the Grand Prize winner's responsibility, including but not limited to: round trip transportation between the Grand Prize winner's residence and any Airport of Origin, activities and ground transportation not expressly included in the Trip, alcoholic beverages, excess luggage fees, customs and immigration fees; passport costs; travel protection insurance, laundry service, merchandise, parking, room service, service charges, souvenirs, spa services and other optional activities, telephone calls and some additional taxes which are not

expressly included in the Trip. Trip components are subject to change without notice. Any depiction of the Trip is for illustrative purposes only and may not reflect actual prize won. Each Winner and his/her Guest are responsible for all in-room charges (e.g., mini-bar, movies), telephone calls, meals, beverages, gratuities, upgrades, personal incidentals, amenities, and any other fees and expenses not specifically mentioned in these Rules. Each Winner will be required to provide a major credit card upon hotel check-in or prior thereto and all in-room charges will be charged to the credit card. Any damage to the room, and/or any other venue related to the Grand Prize, attributed to the Winner and/or his/her Guest will be the responsibility of the Winner.

Any difference between ARV and actual value will not be awarded. Winner is responsible for any transportation not specifically noted in these rules. Certain restrictions, as determined by Sponsor, may apply. If the Group cannot comply with these restrictions or any portion of these Official Rules, the Grand Prize will be forfeited in its entirety and an alternate winner may be chosen. If there is any discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes promotional materials and the terms and conditions of these rules, these rules shall prevail and govern.

The vacation package (and all elements thereof) is not redeemable for cash and is non-transferable except in Sponsor's sole and absolute discretion. The package may not be sold or transferred to any other person or third party. The vacation package may not be combined with any other offer, and travel may not qualify for frequent flier miles, award points or other perquisites. Lost or mutilated tickets will not be replaced. Airline tickets are non-refundable, non-transferable, and are not valid for upgrades. Actual value of the prize awarded depends on a number of factors, including the location of the winner's residence, booking and travel dates and the number of travelers, and therefore may be lower or higher than the ARV at the time it is fulfilled. If the actual value of the prize is less than the stated ARV, the difference will not be awarded. If any portion of the prize is not available for any reason then Disney reserves the right to substitute that portion of the prize with another prize of comparable or greater value.

Travel arrangements must be made through Sponsor's agent and on a carrier of Sponsor's choice. If Winner and Guest cannot travel on the dates specified by Sponsor, the Grand Prize will be forfeited in its entirety and the Grand Prize may be awarded to an alternate winner selected in a random drawing from among all remaining eligible entries. Travel dates will be subject to availability. Flight details are subject to availability and airline carrier's regulations and conditions apply. The Trip may not be combined with any other offer, and travel may not qualify for frequent flier miles, award points or other perquisites. None of the Releasees (as defined below) are responsible for lost or mutilated tickets and none will be replaced. Airline tickets are non-refundable, non-transferable, and are not valid for upgrades. The hotel accommodations and airline tickets will be determined at the sole discretion of Sponsor. If any portion of the Grand Prize is not available for any reason then the Sponsor reserves the right to substitute that portion of the Grand Prize with another prize of comparable or greater value.

Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of the Grand Prize. Winners are not entitled to exchange or transfer prizes or to obtain cash or other substitute, but Sponsor in its sole discretion may substitute prizes of equal or greater value.

Each Winner's acceptance of the Grand Prize and/or the participation in a Grand Prize by a Winner and any Guest of a Winner constitutes the grant to Sponsor and Sponsor's affiliates of an unconditional right and license to use Winner and Guest's full name, any aliases, social media account names, biographical data, voice, and reproductions or renderings of physical likeness (as the same may appear in any still camera photograph, video, and/or any other form), in whole or in part, in all media formats, platforms, and channels now known or hereafter devised, in perpetuity, throughout the universe, for any and all purposes, including, but not limited to advertising, promotion, marketing, publicity, trade or commercial purposes, all without further notice to Winner and/or Guest's, with or without attribution, and without compensation, except where prohibited by law, and Winner and Guest hereby release the Releasees (as defined below in section 8) from any claims or liability arising out of or with respect to such use

Sponsor bears no responsibility if any event, element or detail of a prize is canceled, postponed or becomes unavailable for any reason. Should any event, element or detail of a prize become unavailable, the Sponsor shall have no obligation to the Winner aside from providing the remaining portion of his/her prize, minus any unavailable event, element or detail. The Winner and his/her Guest shall be subject to all terms and conditions printed on any ticket issued in conjunction with a prize. In the event a Winner and/or his/her Guest is denied entry into any ticketed location or is removed or barred from any ticketed location for any other reason, Sponsor is not responsible and no further compensation or award will be provided.

SPONSOR, ITS PARENT, RELATED, AFFILIATED, AND SUBSIDIARY COMPANIES AND THEIR RESPECTIVE OFFICERS, DIRECTORS, AGENTS, EMPLOYEES AND ASSIGNS ARE HEREBY RELEASED AND DISCHARGED FROM ANY AND ALL LEGAL CLAIMS, LOSSES, EXPENSES, LIABILITIES, INJURIES, DEMANDS, DAMAGES, ACTIONS, AND/OR CAUSES OF ACTION THAT ARISE OUT OF AND/OR ARE IN ANY WAY RELATED TO A PRIZE, THE RECEIPT, USE AND/OR ENJOYMENT OF A PRIZE AND/OR THE SWEEPSTAKES. All benefits and payments are personal to each Winner and are not redeemable for cash and are neither assignable nor transferable.

Any portion of a prize not accepted or used by a Winner will be forfeited, and Sponsor shall not be responsible for any inability of a Winner to accept or use any portion of his/her prize for any reason. No substitution or transfer of a prize is allowed except with Sponsor's permission or where required by law. Award of a prize is subject to verification of eligibility and compliance with these Rules. Upon verification of eligibility, Sponsor's designee will contact each winner to book travel. All prizes will be awarded provided a sufficient number of eligible entries are received. Once selected by winner, the Guest cannot be changed without the express consent of Sponsor. A Grand Prize winner may not charge the Guest for participating in the Trip.

7. NOTIFICATIONS TO WINNERS AND REQUIREMENTS TO CLAIM A PRIZE: Each potential winner will be notified by e-mail and/or telephone within two (2) business days from the Random Drawing Date set forth in Section 5 of these Rules. At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate winner may result from any of the following: **[a]** potential winner's failure to (i) respond to Administrator's verification e-mail within two (2) calendar days from the date the verification e-mail is sent, or (ii) return the travel questionnaire within fourteen (14) calendar days from the date it is postmarked as sent by Sponsor; **[b]** the e-mail notification sent by Sponsor/Administrator is returned as undeliverable after three (3) attempts; **[c]** potential winner's failure to provide Administrator with satisfactory proof of age, identity and residency; and **[d]** potential winner's failure to execute and return an Affidavit of Eligibility/Liability/Publicity Release (including, without limitation, his/her Social Security Number as required by law), within five (5) calendar days from the date the form is sent to the potential winner. **Federal, state, territorial, and local taxes and all other expenses not specified herein are the winner's sole responsibility. The award of a prize is subject to applicable withholding requirements.** In the event that a potential winner is disqualified for any reason or does not accept his/her prize, Sponsor, in its sole and absolute discretion, will award the prize to an entrant selected at random from the remaining eligible Entries received for that Entry Period, subject to verification of eligibility and compliance with these Rules. In such case where a prize is not accepted or where a Winner has forfeited, there will, as necessary, be up to three (3) alternate Winners contacted, after which the prize, if not accepted by an eligible Winner, will not be awarded.

8. INTERNET/LIMITATIONS OF LIABILITY: Sponsor, Administrator, their respective parent, related, affiliated and subsidiary companies, their advertising, promotion and web design agencies, all other entities involved in the creation, administration, or fulfillment of the Sweepstakes and their respective successors, assigns, directors, officers, employees, agents and independent contractors (individually and collectively, "Releasees"), are not responsible for technical malfunctions of any kind, including but not limited to interrupted or unavailable network server or other connections; miscommunications; failed, partial, or garbled telephone or computer transmissions; jumbled, scrambled or misdirected Entries or transmissions; phone, electrical, network, computer hardware or software or program malfunctions, failures or difficulties; other errors, omissions, interruptions, or deletions of any kind, whether due to electronic, human, mechanical, printing, production or technical errors or other causes; or for any damage to any person's computer or wireless device related to the Sweepstakes, including without limitation, participation in the Sweepstakes. Additionally, Releasees are not responsible for illegible, unintelligible, late, lost or stolen Entries; incorrect or inaccurate Entry information, whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes; or for any technical or human errors which may occur in the processing of any Entries in the Sweepstakes. Any person attempting to enter using multiple identities or any other device or artifice to enter multiple times in contravention of these Rules, or to interfere with the proper administration of the Sweepstakes, will be disqualified from participation in the Sweepstakes. Additionally, any use of robotic, automatic, macro, programmed, third party or like methods to participate in the Sweepstakes will void any attempted participation effected by such methods and result in the disqualification of any individual utilizing the same. Sponsor and/or Administrator

reserves the right to disqualify any individual found or suspected, in its sole opinion, to be tampering with the operation of the Sweepstakes; to be acting in violation of these Rules; or to be acting with the intent to disrupt the normal operation of the Sweepstakes. If, in the judgment of Sponsor and/or Administrator, the Sweepstakes is compromised by viruses, bugs, non-authorized human intervention or other causes that corrupt or inhibit, or may corrupt or inhibit the administration, security, fairness or intended proper play of the Sweepstakes, so that it cannot be conducted as originally planned or intended, Sponsor and/or Administrator have the right, in their sole respective discretion, to modify the Rules or to cancel, modify, terminate or suspend the Sweepstakes (except where prohibited by law); and in such event, to select the winner by such method as Sponsor in its sole discretion shall consider equitable. **RELEASEES MAKE NO WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NONINFRINGEMENT AS REGARDS TO THE SWEEPSTAKES, ANY PRIZE OR ANY COMPONENT OF A PRIZE OR THE SWEEPSTAKES. AS SOME JURISDICTIONS MAY NOT ALLOW LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OR EXCLUSION OF IMPLIED WARRANTIES, CHECK YOUR LOCAL LAWS TO LEARN IF ANY OF THE ABOVE LIMITATIONS OR EXCLUSIONS MAY APPLY TO YOU.**

9. PRIVACY POLICY AND TERMS OF USE: Any personally identifiable information collected during a Entrant's participation in the Sweepstakes is subject to Sponsor's privacy policy (<http://disneyprivacycenter.com/>), and by submitting an Entry, Entrant agrees to Sponsor's website terms of use (<http://disneytermsofuse.com/>). In the event of a conflict between Sponsor's terms of use and the Rules, the Rules will prevail.

10. GOVERNING LAW: The terms of this Sweepstakes shall be governed by, construed under, interpreted and enforced in accordance with the laws of the State of California without regard to conflicts of laws provisions thereof. Any dispute or claim arising out of or in connection with this Sweepstakes or these Rules shall be resolved individually, without resort to class action, and submitted exclusively to the California Superior Court in and for Orange County (or if the Superior Court shall not have jurisdiction over the subject matter thereof, then to such other court sitting in such county having subject matter jurisdiction) for trial and determination by the court sitting without a jury. **All Entrants consent to the jurisdiction of such court and to the service of process outside the State of Florida pursuant to the requirements of such court in any matter submitted to it, AND THEY EXPRESSLY WAIVE THE RIGHT TO A JURY TRIAL.** ANY CLAIM FOR DAMAGES SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING, WITHOUT LIMITATION, ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM. ONLY SPONSOR AND/OR ADMINISTRATOR MAY RESCIND THIS SWEEPSTAKES AND/OR SEEK INJUNCTIVE AND/OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR RELEASEES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.

ANY CLAIM MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE CAUSE OF ACTION OCCURRED, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.

11. RELEASE: By participating, each Entrant releases and agrees to indemnify and hold harmless Releasees from and against any and all costs, claims, liabilities, damages, or any other injury, whether due to negligence or otherwise, to person(s) or property (including, without limitation, death or violation of any personal rights, such as violation of right of publicity/privacy, libel, or slander), due in whole or in part, directly or indirectly, to participation in the Sweepstakes, or arising out of participation in any Sweepstakes or Sweepstakes or prize-related activity (including travel), or the receipt, use, or misuse of a prize.

12. GENERAL TERMS & AGREEMENT TO RULES: By entering the Sweepstakes, Entrants agree to be bound by and abide by these Rules. In no event will more than two (2) prizes be awarded during the entire Sweepstakes. The Sweepstakes is subject to all applicable federal, state, territorial, and local laws.
